

This memorandum promulgates the Technical Specifications for Construction and Management of Sensitive Compartmented Information Facilities to the Intelligence Community.

As a result of a cooperative effort by physical and technical experts from the IC elements and our industrial partners, these Technical Specifications provide detailed guidance to explain and enhance the physical and technical security standards identified in ICS 705-1, Physical Security Standards for Sensitive Compartmented Information Facilities.

IC elements shall use these Technical Specifications in concert with ICD 705 and ICSs 705-1 and 705-2 to plan, design, and construct or modify SCIFs. As stated within ICS 705-1, full implementation of the standards shall be completed within 180 days of the signature of the standards. This issuance of technical specifications completes these standards and the date of signature of this memo shall serve as the date from which the 180 days shall be counted.
