NAVFAC Munitions Response Quality Assessment Spreadsheet

Department of the Navy (DON) Remedial Project Managers (RPMs) can use the NAVFAC Munitions Response (MR) Quality Assessment (QA) Spreadsheet as a tool to evaluate the quality of their contractor's MR actions. The tool helps to ensure contractual requirements are met. The MR QA Spreadsheet includes a series of questions to ask to support the development of content for the Quality Assurance Surveillance Plan (QASP), as well as during the performance of a project. The tool can also be useful for third-party QA contractors and/or unexploded ordnance (UXO) contractors to perform a third-party or internal review of project performance.
