Navy Open Environmental Restoration Resources (OER2) Webinar on **Accident Prevention Plans (APPs)**

Join us for an OER2 webinar on APPs. The Navy and Marine Corps Public Health Center (NMCPHC) and NAVFAC Southwest will be providing an overview of the APP for ensuring contractor health and safety compliance while conducting inspections, investigations, and cleanup/removal actions at environmental restoration sites. The presentation will provide the tools a Remedial Project Manager (RPM) needs to effectively determine the project health and safety needs and effectively determine the accuracy and applicability of the contractor developed health and safety plans and procedures for the restoration project.



Presentation topics include: 1) explanation of the USACE EM 385-1-1 Manual contractual requirements; 2) understanding and developing an accurate project APP and Site Safety and Health Plan (SSHP); 3) when to use and not use the Abbreviated APP; 4) why Activity Hazard Analyses (AHAs) are a critical component to the APP and site safety; and 5) how to factor health and safety deliverables into a project timeline, NMCPHC's role with document review, and identification of other organizations and agencies that may be part of the Navy review and approval process. Unique project situations and a series of knowledge checks and case studies will be provided to test your understanding and application of health and safety requirements.
