NAVFAC Open Environmental Restoration Resources (OER2) Webinar

The NAVFAC Optimization and Technology Innovation Workgroup has developed a strategy to support sites of varying complexity transition from the Remedy-in-Place (RIP) milestone to the Response Complete (RC) milestone. This OER2 webinar series will discuss the RIP/RC strategy along with other relevant policies and tools in light of the current programmatic goals, including the new Navy ER Program metrics for the RC milestone. Examples will be given for sites of low, moderate, and high complexity to demonstrate the relative timelines and strategies for each type of site. This webinar will be offered in two parts.
